EKU-Centered Rationale for an Interdisciplinary Minor in Asian Studies at Eastern Kentucky University

- An Interdisciplinary Minor in Asian Studies (henceforth, IMAS) is consonant with and supportive of the University's core values, including diversity, excellence, innovation, opportunity, access, collaboration, and student success.¹
- It is consonant with and supportive of the University's aspirations: "EKU aspires to and shall become an institution of national distinction."²
- It is consonant with and supportive of the goals articulated by President Michael Benson to internationalize the campus.³
- An IMAS provides students and faculty an opportunity to integrate Asia-centered courses in various disciplines into a coherent area of study.
- Current faculty members whose areas of research expertise and/or teaching competence include Asia belong to the following academic disciplines: Comparative Literature, Criminal Justice, Cultural Studies, Dance, Economics, English, Foreign Languages, Geography, History, Justice Studies, Linguistics, Management, Philosophy, Psychology, Religion, Sociology, and Women and Gender Studies.⁴
- Because of its interdisciplinary nature and broadly humanistic outlook, an IMAS is poised to strengthen the University's liberal arts programs.
- It is poised to contribute to the development and graduation of "informed, critical, and creative thinkers who communicate effectively," which is the theme of the University's Quality Enhancement Plan.⁵
- In terms of recruitment, development, and retention of not only high-quality students but also high-quality faculty, it helps make the University more competitive, both locally and nationally.
- Nationally, among 56 approved ECU benchmark institutions,⁶ 32 of them, or 57%, offer a Major, Minor, Concentration, or Certificate in Asian Studies, or something closely related.⁷

- Locally, among 4 approved ECU benchmark institutions in the Commonwealth (i.e., Morehead State University, Murray State University, Northern Kentucky University, and Western Kentucky University),⁸ 3 of them (i.e., Murray, Northern, and Western), or 75%, offer a Major, Minor, Concentration, or Certificate in Asian Studies, or something closely related.⁹
- Murray offers both a Japanese Studies Major and a Japanese Studies Minor. Western offers an Asian Religions and Cultures Major, an Asian Religions and Cultures Minor, and an Asian Studies Minor.
- In addition, the following institutions in the Commonwealth offer a Major, Minor, Concentration, or Certificate in Asian Studies, or something closely related: Berea College (both Major and Minor), Centre College, Georgetown College, Transylvania University, University of Kentucky (both Major and Minor), and University of Louisville (both Major and Minor).
- Although the Interdisciplinary Minor aims to become more comprehensive with the expansion of resources related to Asian Studies, in its current stage, it can rely upon existing resources, including the availability of office space in Case Annex and the expertise of current faculty.¹⁰
- In consonance with current university strengths, especially faculty/staff and resilience/use of resources,¹¹ one of our guiding principles is to make the best use of existing resources without compromising excellence.

RE: Graduation cords for Mock Trial

EKU's Mock Trial Program participates in annual regional and national competitions held by the American Mock Trial Association (AMTA). AMTA has recently introduced graduation cords for its member schools, and we would like to make them available to our students.

As for other honor-society cords, there must be appropriate standards within the program for receiving this honor. We propose the following:

- average grade of "B" (3.0) or higher in Mock Trial coursework; and
- either
 - 2 years of participation on an ECU team at an AMTA regional tournament; or
 - 1 year of participation on an ECU team at an AMTA national tournament (Opening Round Championship or National Championship Tournament).

S2 Admission for Certain MAT 090 Level Applicants

Background: The retention and academic success of students entering at the 090 level of proficiency has a significant impact (negative drag) on our retention and graduation rates. For Fall 2013 the number of students who, at the time of admission, had 090 level test scores exceeded 1200 students.

Of the students who matriculated into the Fall 2013 cohort **279** continued to need 090 level remediation; primarily in Math. The two charts below indicate retention data for the Fall 2013 cohort:

In looking at the entire MAT 090 group, the retention data indicates that students who scored 15 or below on the Math Subject Test Score retained at 43% versus while those with MAT Subject Test Scores at 16 or above retained at a rate of 56%.

There were 373 students admitted for Fall 2013 who had MAT subject scores below a 16. There were 1007 students when students with a MAT subject score of 16 were added to the criteria.

Fiscal Consideration: The elimination of all 090 levels instruction in the Fall term is not practical given the number of admitted students (1200+) involved. If only MAT is considered, that number still exceeds 1000 students. The university is not in a financial position to deny these students admission nor risk forcing all 1000 students to consider attending Summer Bridge before being granted admission for the Fall term. However, the retention differential between students above and below the Math Subject Score mark of 16 is 13% and is significant enough to warrant strong consideration of an alternative admission standards for students with low Math Subject Test Scores.

Proposal: Admit students who apply for the Fall term, but who have MATH Subject Test Scores of 15 or less (or SAT equivalent), to the summer term with the requirement to enroll in the Summer Bridge program under the admission type S2 (Special Admit Category 2). S2 students, who, prior to registration, submit test scores indicating a MATH score of 16 or greater, would not be required to attend Summer Bridge and would have their term of attendance changed to Fall. However, these S2 students would be required to participate in the Fall Bridge cohort unless they completely test out of developmental Math. S2 students attending Summer Bridge would not be permitted to enroll in the Fall

term until they pass MAT 090 and would be required to remain in the Bridge program until meeting the criteria for release.

Proposed Catalog Language to be added to Directed Admissions: *Students applying for the Fall term who have an ACT (or equivalent SAT) Math subject score below 16 will be granted Success First Admission for the summer term and must successfully complete directed coursework to remain enrolled.*
